The District engages stakeholders through monthly meetings, newsletter communications, social media posts, parent club outreach, annual parent surveys, annual student surveys, and frequent conversation with families. We are a small rural community and our parents are partners in developing the direction of the schools. We surveyed families, students and community members (trustees) to determine their feedback on academics, school culture, and safety of facilities. We utilize family feedback regarding school participation, support, and communication to create a more collaborative partnership between staff and families. The goal would be to increase the level of community engagement and partnership because of informed decision-making based on family feedback.

A majority of parents feel satisfied with the way the schools are addressing the needs of their students. There is no parent advisory committee as both schools are small (under 20 students); parents can also attend Board meetings. Currently feedback is through parent surveys and monthly parent meetings.

As reflected above, our small setting allows for ongoing feedback and communication with our parents, neighbors, students and board members. We are relatively geographically isolated in this idyllic rural setting. We have maintained a focus on student engagement and social emotional wellbeing throughout the history of the school but most especially across the last year. Our plan is to continue this learning with added support in the areas of intervention. This comes in the form of increasing the amount of time and staffing that we are dedicating toward intervention. This is an extension of our overall plan that can be found in our LCAP - directly influenced and supported by staff, students, parents/families and our board. In consultation with our special education staff and the Marin County SELPA, we found additional support for this type of service for students to address any significant - potentially heading off a need for more extensive services.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
